TERMS AND CONDITIONS

The promoter is Bidfood – Chef's Shop Ggeberha branch.

Any persons entering or participating in this giveaway ("Participant") accept and agree that by entering this lucky draw they have had an opportunity to read and consider these Terms and Conditions and that they are bound by these Terms and Conditions.

Lucky draw date :10 May 2025,17 May 2025, 24 May 2025 and 31 May 2025

1. What is the Prize;

3. How to Participate;

The Winners will be contacted on each of these mentioned dates via email or telephone.
