1. What is the Prize;


- 1.1. Participants stand a chance of winning one Potjie pot filled with restaurant quality foods from Chef's Shop and R1000 cash ("Prize").

- 3.3.7. Participant video must be "Portrait" and not more than 1 minute long. Please be mindful of language used.
- 3.4. Each team will get access to purchase exclusive discounted potjie bundles from Chef's Shop to prep for the big day.
- 3.5. Then on the event day of 28 June 2025, from 13:30, the public will have the opportunity to donate R40 to taste and vote for their Perfect Potjie champs by means of a voting ballot and ballot box.
 - 3.2 (1) winner will be selected by a 50% public and 50% judges vote on 28 June 2025. The Winner will be notified on the day of the event, 28 June at Chef's Shop Gqerbeha premises
 - 3.3 Once a winner has been chosen and notified, the winner will be awarded with their prize on the day of the event, Saturday 28 June 2025 at Chef's Shop Gqeberha (at 12-18 16th Ave, Walmer, Gqeberha, 6070.)
 - 3.4 By participating in the competition, Winner's consent to the Promoters obtaining, retaining, using and otherwise processing, the Personal Information furnished to the Promoters. The Winners also consent to their names being published on the websites and lawfully gives the rights to any images being posted across various social media pages of the Promoters.

 - 4.9.5. Must display what Potjie you have made with a printed recipe card of ingredients
 - 4.9.6. Proof of some of the ingredients for the potjie being bought from Chef's Shop must be provided to competition officials as proof of entry
 - 4.9.7. Rice or side dishes to be made off site
 - 4.9.8. Fire coals will be provided by Chef's Shop
 - 4.9.9. Braai and stand per team supplied by Chef's Shop
 - 4.9.10. Voting will take place with a ballot voting box and voting slips
 - 4.9.11. To taste and cast votes, the cost is R40 per person (promo code "DONATION" of which the proceeds of the food tasting will go to charity chosen by the winning team)
 - 4.9.12. Entrants are encouraged to share all potjie cook-off related content on their personal social media accounts
 - 4.9.13. Participants must be at the shop at 8:00am and start prep work
 - 4.9.14. Potjies need to be on the stoves by 9:00am



4.9.15. Potjie dishes must be complete and ready for tasting at 13:30pm4.9.16. Participants must clean up their stations after the prize giving ceremony
