

RICH'S CROISSANT COMPETITION

("Competition")

TERMS AND CONDITIONS

Rich Products Corporation and Bidfood (Pty) Ltd. are contracted to promote this competition here ("The Promoter").

Any persons entering in this competition (" The Participant") accept, agree and are bound by these Terms and Conditions.

1. Prize
